

LEGAL NOTICE

The Borough of Kennett Square will hold a public meeting on Monday, December 4, 2017 at 7:00 p.m., to consider the 2018 Preliminary Budget, to conduct general business, and to consider enactment of an ordinance establishing the tax rate for Fiscal Year 2018.

The meeting will be held at the Red Clay Room, Kennett Fire Company No. 1, 423 Dalmatian Street, Kennett Square, PA 19348. The public is invited to attend and comment.

The proposed ordinance may be examined or obtained during regular business hours at the offices of the *Daily Local News*, 250 North Bradford Avenue, West Chester, PA 19382; and at Borough Hall, 120 Marshall Street, Kennett Square, PA 19348. An attested copy of the ordinance has been sent to the Chester County Law Library, 201 West Market Street, Suite 2400, West Chester, PA 19380, and the Kennett Library, 216 East State Street, Kennett Square, PA 19348, and is available for public inspection.

A full copy of the proposed 2018 budget may be examined at Borough Hall and the Kennett Library during normal business hours.

The proposed ordinance is as follows:

AN ORDINANCE OF THE BOROUGH OF KENNETT SQUARE, COUNTY OF CHESTER, COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING THE TAX RATE FOR THE FISCAL YEAR 2018

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the Borough of Kennett Square, County of Chester, Commonwealth of Pennsylvania.

SECTION 1. That a tax be, and the same is, hereby levied on all property subject to taxation within the said municipality for the Fiscal Year 2016 as follows:

Tax rate for general Borough purposes, the sum of 6.35 mills on each dollar of assessed valuation, or the sum of .635 cents on each one hundred dollars of assessed valuation.

The same being summarized in tabular form as follows:

Mills on Each Dollar of Assessed Valuation, Cents on each One Hundred Dollars of Assessed Valuation, respectively;

Tax Rate for General Purposes – 6.35 Mills, .635 Cents

TOTAL: 6.35 Mills, .635 Cents

SECTION 2. That any ordinance, or part of ordinance, conflicting with this ordinance be, and the same is hereby repealed insofar as the same affects this ordinance.

SECTION 3. This ordinance shall take effect and be in force from and after January 1, 2018.

Tax Rate for General Purposes – 6.35 Mills, .635 Cents;


