

NOTICE - The Borough Council of the Borough of Kennett Square will hold a public meeting on **Monday, December 3, 2018** at 7:00 PM to conduct a **public hearing** and to consider enactment of an ordinance amending **Chapter 23, Zoning** of the Municipal Code of the Borough of Kennett Square.

The hearing will be held at the Red Clay Room, Kennett Fire Company No. 1, 423 Dalmatian Street, Kennett Square, PA. The public is invited to attend and comment. Following the conclusion of the hearing, the Borough Council may consider enactment of the ordinance.

The proposed ordinance may be examined or obtained during regular business hours at the Kennett Square Borough Hall, 120 Marshall Street, Kennett Square, PA and the office of *Southern Chester County News*, 307 Derstine Avenue, Lansdale, PA. The following is a complete copy of its content:

It is hereby enacted and ordained by the Borough Council of the Borough of Kennett Square, Chester County, Pennsylvania that Chapter 23, Zoning, Section 30, "Accessory Uses" of the Municipal Code of the Borough of Kennett Square shall be amended as follows:

Section 1. Code Subsection 23-30(c)(2)(B)(iii) is hereby deleted in its entirety.

Section 2. Code subsections 23-30(c)(2)(B)(iv) and (v) are renumbered as subsections (iii) and (iv) respectively.

Section 3. All other ordinances or parts of ordinances are hereby ratified and reaffirmed, except insofar as they are inconsistent herewith.

Section 4. This Ordinance shall become effective five (5) days after the adoption and enactment hereof.

AN ORDINANCE AMENDING THE ZONING CODE OF THE BOROUGH OF KENNETT SQUARE TO DELETE IN ITS ENTIRETY CHAPTER 23, ZONING, SECTION 30, “ACCESSORY USES”, SUB-SECTION 23-30(c)(2)(B)(iii) OF THE ORDINANCE
